3. Digital photos may be combined and uploaded to your online account (save as a pdf.) OR color printed and left on site with permit documents.

NOTE: All the documents will become part of the inspection record. On-site inspections, per Florida Building Code 110, may be required by the Building Division to verify Code compliance.
