

**FIRST AMENDMENT TO AGREEMENT  
FOR CONTRACTOR SERVICES**

**THIS AMENDMENT** is made as of the 5<sup>th</sup> day of September 2008, between **THE CITY OF LEESBURG, FLORIDA**, a Florida municipal corporation, who's address is 501 West Meadow Street, Post Office Box 490630, Leesburg, FL 34749-0630 (hereinafter referred to as the "CITY"), and **LEWIS TREE SERVICE** whose address is 300 Lucius Gordon Drive, West Henrietta, NY 14586 (hereinafter referred to as the "CONTRACTOR").

**WITNESSETH:**

**THAT**, on October 1, 2005 the CITY and CONTRACTOR entered into a contractor services agreement whereby the CONTRACTOR agreed to provide tree trimming and removal services to the CITY (hereinafter referred to as the "Agreement"). **NOW**, the parties wish to extend the term of the Agreement and have entered into this Amendment for that purpose.

**NOW, THEREFORE**, in consideration of the mutual benefits accruing to the parties to this Amendment and for other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. **Recitals.** The above recitals are true and correct and are incorporated by reference herein and made a part hereof.
2. **Amendment.** The parties agree to extend the term of the Agreement to September 30, 2009.
3. **Modification.** Except as specifically modified by this Amendment, all terms and conditions of the prior agreement shall continue in full force and effect as originally executed. Nothing herein shall be deemed or construed to amend or modify any other contract or undertaking between the CITY and the CONTRACTOR other than as defined above.
  - a. **Unit Prices.** Original unit prices are modified per attached "EXHIBIT A" - Unit Price Schedule and are effective October 1, 2008.
  - b. **Emergency Event Response.** The CONTRACTOR will be notified in writing by the CITY if their services are needed in response to an emergency event. Upon written notification all routine work will stop and future work performed by the CONTRACTOR will be emergency event related. All invoicing will reference the CITY emergency event Work Request & Job Number provided in the written notification. The CONTRACTOR will be notified in writing when their services related to the emergency event are no longer needed.
